



2017 PRICE SHEET UPDATES

Community Fee: \$3,500 / \$5,000

A one-time community fee of \$3,500 is required of all new residents prior to admission, and \$5,000 for a two-person occupancy. This fee covers the cost of improvements made within our community.

Respite Care

Cost: Starting at \$170/day
Supervised care for a temporary stay is available. Our program offers all available support services in a fully-furnished, one-bedroom apartment. Short-term stay apartments will require a 30-day minimum.

Option 1: Monitored Independent Program

This program is utilized by residents who are clinically independent but want the convenience of basic amenities in a supportive environment.

Services & Amenities include:

- 24-hour on-site nursing
- 24-hour building security
- 3 daily safety checks
- Emergency pendant system
- All utilities (except phone and cable*)
- Apartment (unfurnished) featuring kitchenette and full bathroom
- Personal heat and air conditioning unit
- Weekly housekeeping
- 3 delicious daily meals prepared by our chef
- Daily weekday transportation service (within 10-mile radius)
- Comprehensive recreational programming to serve mind, body, and spirit

*Optional Amenities include:

- Valet laundry service available - \$30 per bag per person
- Senior TV satellite program - \$60 per month (\$75 one-time installation fee)

Option 2: Customized Support Services Program

In addition to the services and amenities of the Monitored Independent Program (Option 1), the Customized Support Services Program offers additional à la carte services as residents need them.

Harmony Hall designs its levels of care to meet the needs of each individual. These needs will determine the services that are provided.

Caregiver Visits

Cost: \$15/15 minutes
Caregivers can provide various services to assist with Activities of Daily Living (eating, bathing, dressing, toileting, transferring /walking and continence.) Caregiver visits can range from one brief 15-minute visit to longer, more involved visits.

Medication/ Management & Insulin Care

Cost: \$20/day
A registered nurse supervises the administration of medication. Certified medical technicians administer the medications. Regular contact with the resident's physician is maintained. Specific services include:

- Blood pressure monitoring
- Blood sugar tests
- Insulin injections

Nurse Visits

Cost: \$25/visit
Nursing visits may involve:

- Telephone coordination with family, lab services, and physicians
- Physician-ordered collection of lab samples
- Apartment visits for fall assistance and assessment
- Wound or colostomy care
- Executing physician orders and medication changes
- Family-requested visits
- Emergency visits

Option 3: Safe Harbor Program

The goal of the Safe Harbor program is to provide comprehensive support. The level of care is based on the amount of time that the resident requires with the clinical staff and is determined by a registered nurse's assessment. This option offers all of the services of the Customized Support Services Program (Option 2) at inclusive rates.

Safe Harbor Basic Level	\$48/day, plus apartment rental cost
Safe Harbor Plus Level	\$57/day, plus apartment rental cost
Safe Harbor Extended Level	\$70/day, plus apartment rental cost
Safe Harbor Complete Level	\$84/day, plus apartment rental cost
